General Instructions

- There is NO CET for admission in M.Sc. Forensic Science Program this year and admission is purely on merit basis under the prevailing rules of Government of Maharashtra/affiliating university.
- Currently, only **B.Sc. Forensic Science** is eligibility to get admission in M.Sc. Forensic Science. Aggregate percentage of B.Sc. Forensic Science will be considered for admission. In case of a tie, aggregate percentage of 12th will be considered. Further tie-breaking will be done the basis of aggregate percentage of 10th and age (older will be preferred).
- This year, out of 25 seats, 20 seats are reserved for Home University, 3 seats for other universities of the State of Maharashtra and 2 seats for other States.
- Reservation policy will be followed as per the prevailing norms of Govt. of Maharashtra.
- Admission will be given to the eligible candidates if his/her name appears in the merit list displayed by the Institute on the website. Just appearance of the name doesn't guarantee the admission unless he/she fulfils the criteria laid down by the Institute as per the guidelines of the Govt. of Maharashtra/affiliating university.

Instructions for counselling cum admission

- Counselling cum admission will be strictly offline based on the category-wise merit list.
- Category-wise details (rank/cut off) of the candidates will be displayed for the first counselling on 22nd of October, 2021 at 7.00 PM.
- Only the candidates having more than the mentioned rank/cut off have to appear in person for the respective counselling cum admission.
- Candidates need to bring all the relevant certificates in original, one set of self-attested copies of all the relevant certificates and two passport size photographs. Failing which, no claim for admission will be entertained.
- No claim for admission will be entertained for the candidate who doesn't appear in person for the respective counselling cum admission.
- Second counselling cum admission is subject to availability of seat.
