#### General Instructions

- Admission is purely on merit basis under the prevailing rules of Government of Maharashtra/affiliating university after verification of Original Documents.
- A Candidate seeking admission must bring the followings on the date of admission:
  - a) Original Mark Sheets (all semester up to final year of Graduation)
  - b) Original T.C.
  - c) Caste certificate (if applicable)
  - d) Caste Validity (if applicable)
  - e) Gap Certificate (if applicable)
  - f) Recent Passport size photographs
  - g) Prescribed fees
- Aggregate percentage of Graduation will be considered for admission. In case of a tie, aggregate percentage of 12th will be considered. Further tie-breaking will be done the basis of aggregate percentage of 10th and age (older will be preferred).
- Out of 40 seats, 32 seats are reserved for Home University, 4 seats for other universities in the State of Maharashtra and 4 seats for other States.
- Reservation policy will be followed as per the prevailing norms of Govt. of Maharashtra.
- Admission will be given to the eligible candidates after document verification, if his/her name appears in the merit list displayed by the Institute on <https://gifsa.ac.in>.

- **Just appearance of the name doesn't guarantee the admission unless he/she fulfils the criteria laid down by the Institute as per the guidelines of the Govt. of Maharashtra/affiliating university.**
