- c. OrganizingSeminars, Workshops, etc...
- d. Exchange of academic information and library materials, study materials and other e-resources.
- e. Conducting field visits and Study tour.
- f. Promoting other academic co-curricular cooperation as mutually agreed
- 3. The implementation of specific activities based on this MoU will be separately negotiated and agreed between institutes which carry out the specific activities and will be subject to a separate written agreement. Each Party agrees to carry out these activities in accordance with the laws and regulations after full consultation and approval of both the parties.
- 4. It is understood that the implementation of any of the types of co-operation stated in Clause 2 shall depend upon the availability of resources and financial support of the Parties concerned.
- 5. Both Parties agree that prior written approval is required before using the other Party's name, logo, or other Intellectual Property rights in any advertising or associated publicity.
- 6. This MoU may only be amended or modified by a written agreement signed by the representatives of each Party.
- 7. This MoU is valid for a period of Five year from the date of signing by the authorized signatories of each Party. Each Party shall review the status of the MoU at least three months before the end of the five year period to determine whether it wishes the MoU to continue and, if so, any modifications that might be necessary. The period of validity of this MoU may only be extended by the mutual written consent of both Parties.
- 8. This MoU may, at any time during its period of validity, be terminated by one of the Parties upon prior notice to the other in writing not later than six months before the termination date.
- 9. The Parties may disclose certain confidential information to the other in relation to any future proposal made under this MoU. Each Party therefore agrees that the contents of this MoU and the negotiations in relation to any future proposal remain
