I Parties: The parties to this understanding are Jalna Education Society's R. G. Bagdia Arts, S. B. Lakhotia Commerce & R. Bezoni Science College, Jalna Maharashtra as a representative for availing guidance and facilities for creating Forensic and exploring scientific and analytical approaches, learning skills related to several disciplines of Government Institute of Forensic Science and utilizing analytical facilities available with the Institute and here-in after referred as Jalna Education Society's R. G. Bagdia Arts, S. B. Lakhotia Commerce & R. Bezoni Science College, Jalna and Government Institute of Forensic Science, Aurangabad-431004. As representative for creating awareness in Forensic Science and providing facilities and guidance in Forensic science approaches, analytical skills and other related work and providing facilities, available equipment, Laboratory Techniques (GCMS, HPLC, PCR, Gel Doc facility, Ultrasonic exposure, Electrophysiological data acquisition etc.) with the Institute.

II. General responsibilities for both parties:

- a. The parties will work together to conduct research in the field of Forensic Sciences, Medicinal Plant analysis emphasizing on various practical aspects, learning skills related to Forensic Science and other analytical facilities. Advanced practical Laboratory exposure, Ultrasonic exposure, Computational data acquisition, Library etc. depending on the projects and facilities available with either institutes, faculty members or their expertise in the concerned field.
- b. Parties will not impose of making compulsory to create the facility for a special project, if any. In case if funds will be available from sponsored grant-in-aid providing agencies like AICTE, DST, INSA, ICMR, DAE, DBT, UGC & other Govt. funding agencies, Management of the college or any other agency etc. the specialized facilities can be created in interest of the research projects with mutual benefit of both the parties. The ownership and possession of such facility will be with the party to whom the financial assistance will be provided. The maintenance of such equipment will be done by the party who possesses it.
- c. The cost of consumable and utilities for research project and operation of the instrument will be done on mutual understanding and availability of funds with either party with no additional financial burden on either party.

Both parties agreed to share the facilities available for utilization for research project on academic concessional basis. (As per list attached)

- f To organize various scientific events emphasizing the significance of Scientific and Research approach in understanding science and nurturing forensic research enriching interdisciplinary awareness among students and faculty.

- f. To jointly organize and or host Conferences/Seminar/ Workshops/ Training programmes.





- To jointly organize and or host Conferences/Seminar/ Workshops/ Training programmes


Activities under MoU
